Extension of PUSU Deadline

On 3 February 2026, CyanConnode announced that it had received an indicative non-binding approach from Esyssoft Holding Ltd ("**Esyssoft**"), a subsidiary of International Holding Company PJSC (ADX: IHC), regarding a possible all cash offer for the Company (the "**Possible Offer**"), valuing its entire issued and to be issued ordinary share capital at £35 million, representing approximately 9.75 pence per share.

On 3 March 2026, CyanConnode announced that it had negotiated and received a further non-binding proposal from Esyssoft regarding a possible all-cash offer for the Company. The revised proposal values the Company's entire issued and to be issued ordinary share capital at £37.5 million, equivalent to 10.44 pence per share (the "**Revised Proposal**").

Having considered the Revised Proposal carefully with its Financial Adviser, the board of directors of CyanConnode (the "**Board**") has confirmed to Esyssoft that the Revised Proposal is at a level that the Board would be willing to recommend unanimously to CyanConnode shareholders, should a firm intention to make an offer pursuant to Rule 2.7 of the Code be announced on such financial terms, subject to agreeing other key terms of Esyssoft's proposal and definitive transaction documentation.

Pursuant to the Company's announcement on 26 May 2026, Esyssoft is required by no later than 5.00 p.m. on 23 June 2026 (the "**PUSU Deadline**") either to announce a firm intention to make an offer for CyanConnode in accordance with Rule 2.7 of the Code or to announce that it does not intend to make such an offer, in which case the announcement would be treated as a statement to which Rule 2.8 of the Code applies.

Esyssoft continues to progress its confirmatory due diligence, which remains ongoing and at an advanced stage, with the parties continuing to work through the final remaining elements of that process. Accordingly, the Board has requested, and the Takeover Panel has consented to, an extension to the date by which Esyssoft is required either to announce a firm intention to make an offer for the Company in accordance with Rule 2.7 of the Code, or to announce that it does not intend to make an

offer, in which case the announcement would be treated as a statement to which Rule 2.8 of the Code applies. Such announcement must now be made by not later than 5.00 p.m. (London time) on 21 July 2026. This deadline can be extended with the consent of the Takeover Panel in accordance with Rule 2.6(c) of the Code.

There can be no certainty that any firm offer will be made for the Company.

Pursuant to Rule 2.5 of the Code, Esyssoft reserves the right to vary the form and/or mix of the offer consideration and vary the transaction structure. Esyssoft also reserves the right to make an offer for CyanConnode on less favourable terms than those described in this announcement: (i) with the agreement or recommendation of the Board; (ii) if a third party announces a firm intention to make an offer for CyanConnode which, at that date, is of a value less than the value of the Revised Proposal; or (iii) in the event of an announcement by CyanConnode of a Rule 9 waiver transaction, pursuant to Appendix 1 of the Code or a reverse takeover (as defined in the Code). In addition, if CyanConnode announces, declares or pays any dividend or makes any other distribution or return of value to its shareholders after the date of this announcement, Esyssoft reserves the right to make an equivalent reduction to the Revised Proposal price.

Shareholders should note that the Company continues to be in an 'Offer Period' in accordance with the Rules of the Code. Attention is drawn to the disclosure requirements of Rule 8 of the Code, which are summarised below.

An Opening Position Disclosure must contain details of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s). An Opening Position Disclosure by a person to whom Rule 8.3(a) applies must be made by no later than 3.30 p.m. (London time) on the 10 business day following the commencement of the offer period and, if appropriate, by no later than 3.30 p.m. (London time) on the 10 business day following the announcement in which any securities exchange offeror is first identified. Relevant persons who deal in the relevant securities of the offeree company or of a securities exchange offeror prior to the deadline for making an Opening Position Disclosure must instead make a Dealing Disclosure (as defined in the Code).
